Release and Indemnity Agreement, Assumption of Risk  
February 17-18, 2012

In Consideration of myself or my child being permitted to participate in any way in the Michigan High School X-C Skiing Championship (February 17-18, 2012), I represent that I do, on behalf of myself OR my child:

1. acknowledge, agree and represent I fully understand the nature of Nordic skiing and the Michigan High School X-C Skiing Championships and that I or my child are qualified, in good health, and in proper physical condition to participate in such activity.

2. fully understand that (a) the Michigan High School X-C Skiing Championship involves risk and dangers of serious bodily injury (b) these risks and dangers may be caused by my own (or my child's) actions or inactions, or the actions or inactions of others participating in the Michigan High School X-C Ski Championship, and/or the condition of which the Michigan High School X-C Ski Championship takes place.

3. Release of all claims:

I hereby agree, for myself and for my child to release, discharge and covenant not to sue the above listed organization (Michigan High School X-C Skiing Championship) or its parent organization, its respective administrators, directors, agents, officers, members, volunteers, and employees, any sponsors and advertisers. I do hereby fully and forever release and discharge, and agree to indemnify and hold harmless Michigan Technological University, its Board of Control, employees and agents from any and all claims, demands, damages, or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, for bodily injury, death or property damage resulting from or arising out of or in connection with my participation in the Michigan High School X-C Ski Championship; excepting only such claims or causes of action arising from the willful misconduct by Michigan Technological University, its officers, agents or employees. I grant permission for the use of my name and/or likeness relating to my participation in this event, and I waive all rights to any future compensation to which I may otherwise be entitled as a result of the use of my name or likeness.
